Nordic Conference 2006

The conference will focus on the importance of cultural activities in prison and address such themes as the ethical culture, artwork, library, the culture of prison and prisoners and role of ITC for future prison education.

Council Of Europe News

Revision of the European Prison Rules - As outlined in previous editions of the Magazine, last year the Council of Europe began the process of reviewing and updating **European Prison Rules Recommendation No. R (87) 3**. Following consultations with members, the EPEA responded to the initial draft and we are delighted to report that the COE has acted in accordance with our suggestions. In fact, the wording proposed by the EPEA was accepted almost verbatim. We would like to thank all those members who responded to our request for feedback and ideas, and also the various branches and organisations that lobbied in tandem with us. It is heartening to see that we can and do make a difference not only in practice on a day to day basis but also at this important policy level.

Norway leads the way

The Norwegian Government recently produced a **White Paper on Education in Prison** that has directed parliament to strengthen the provision of prison education. The White Paper came about in response to a research-based evaluation of the prison education service carried out from 2000 – 2003, which in turn secured increased funding for prison education. It is a major achievement to have the concept and role of prison education not only debated in parliament but also acted on in such a positive manner. Our congratulations to FOKO (the EPEA's Norwegian branch) for the pivotal role they played in bringing the White Paper to fruition. Meanwhile, the UK government has delivered a Green Paper - **Reducing Re-offending through Skills and Employment**, produced by the Department for Education and Skills, Home Office, and Department for Work and Pensions.

It is being organised by the Prison Service of the Czech Republic, in association with the European Prison Education Association (EPEA).
